Dear tenant

At the meeting in the housing association on 25 January 2024 it was decided that Værebros Park, where you are living, is to be renovated and we therefore invite you to a personal rehousing interview.

In order to handle you and your housing situation, we need to have an interview with you where we can clarify the wishes you have to any temporary rehousing dwelling or to another permanent dwelling after the renovation.

We have allocated 16 days in August where we will conduct individual interviews with the tenants. 2 employees from DAB will be present at the interviews. The interviews will take place in the tenants' building at **Værebrovej 76, 2880 Bagsværd**.

The rehousing form will be reviewed and completed at the individual interview. To the extent that you are able to do so, you are welcome to complete the form fully or partially before the interview.

The interview is expected to last 15 minutes.
